**\*\*\* It might rain, please pack accordingly\*\*\***

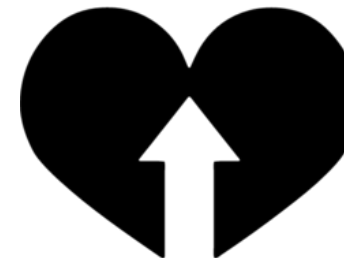
### NOTE
